# **Constitutional Amendments**

## 1. Article 1 sec. 7:

No Bills shall be passed that has a Bill hidden within, or a Bill that is not titled according to its intent, or any Bill that has not been read and properly debated.

#### 2. Article 1 sec. 8:

To coin and print the Money of the United States, and provide interest of no less than twenty percent to the taxes collected as equity for the people, regulate the value thereof, and of foreign Currency, and fix the standard of Weights and measures;

#### 3. Article 1 sec 8:

To assist the several States with helping the Poor, and insure access to good quality Education and Healthcare; and to offer aide to the several States and foreign countries during times of disaster;

#### 4. Article 1 sec. 9:

No Federal Income Tax shall be laid, unless the Taxes collected are apportioned by a flat tax percentage rate not to exceed five percent, excluding corporate taxes which shall not exceed twenty five percent.

## 5. Article 1 sec. 10:

If Congress discontinues making its own Money and or regulating the value thereof, the several States shall be permitted to make its own Money; and regulate the value of such provided that Congress no longer regulates the value of it, and it shall be valid tender in all States and territories of the United States.

## 6. Article 1 sec. 11:

The Treasury of the United States shall consist of the IRS, National Reserve, and the Mint; the IRS shall collect the taxes and deposit the amount collected in the National Reserve; the National Reserve shall send a receipt of the Deposit to the Mint; the Mint shall coin and print the money for the Treasury of the United States not to exceed the interest allowed by law as equity for the people.

The Interest rate shall not exceed two hundred percent to last for a longer term than two years; unless approved by Congress.

# 7. Article 1 sec. 12:

The agencies created to offer entitlements, shall collect a tax from employees that will have interest applied to it by the Treasury of the United States as equity for the people, not to exceed the interest allowed by law.

8. Article 7 the bill of rights – 1<sup>st</sup> amendment:

Congress shall acknowledge that Christian principles are the founding morals of this Nation, and shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof and the several States, shall teach the moral character and principles of our founding fathers in public schools:

No law shall abridge the freedom of speech, or of the press;

The right of the people peaceably to assemble, and to petition the Government for a redress of grievances, shall not be denied.

9. Article 7 the bill of rights -2nd amendment:

A well regulated Militia is necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed; not to be construed to deny the due process of Law on persons found guilty of committing a crime with a firearm or to be found mentally unfit.
