Mandate 12: Political Elections;

Election Debates:

The State and Federal Government shall provide a broadcast network and website that will feature the debates and each candidates political plan and comments so that each candidate has an equal opportunity to be seen and heard by the people, and the voters shall be allowed to vote for any candidate to run for office.

Mandate 21: Employment and Unemployment Agency;

Agency:

The agency acts as an unemployment and employment agency to keep an accurate record of unemployment and it guarantees all able bodied people the right to work, and to collect unemployment while in college or between jobs, and it provides skill testing for jobs that require certification, security background checks on certain job fields, and job placement with employers. The agency cannot mandate a job applicant to do any work that does not meet the job applicants work preferences, and skill testing is exempt for apprenticeship programs.

Employers:

To put a stop to illegal aliens working, job applicant discrimination, unreasonable testing, and background checks, all Employers with an (EIN) Employer Identification Number must request registered job applicants through this agency.

Job Applicants:

Persons of legal age must register to work through this agency, and persons working will be required to pay a tax into this agency with equity applied by the Government as described under mandate 16.

Mandate 24: Wage Protection act;

Law:

To protect the wage level of employees after Minimum wage increases, employers will have to increase the wage of their employees by the same rate as the minimum wage increase. (Example; Say the minimum wage is \$8.00 per hr, and an employee makes \$10.00 per hr, and now the minimum wage is increased to \$9.50 per hr, the employee making \$10.00 per hr would now be making \$11.50 per hr).

Mandate 25: Union Shops;

Strikes:

Employers must negotiate with Union members to maintain production, and must not use outside help or hire employees during a Union strike.

Mandate 26: Minimum wage Law;

Minimum wage based on educational requirement:

No Requirement = \$10.00 per hr
Diploma or GED = \$15.00 per hr
Certification = \$20.00 per hr
Associates Degree = \$30.00 per hr
Bachelors Degree = \$40.00 per hr
Masters Degree = \$50.00 per hr
Doctoral Degree = \$60.00 per hr
